- DETENTION -** 1 hr free to load / unload on live shipments **\$100.00/ hr thereafter**
- HAZARDOUS -** Must have notification of all hazardous load prior to assure haz-mat qualified driver is dispatched for shipment **\$75.00**
- TANK -** If tank certification is required for shipment **\$100.00 / per one way**
- REEFER -** Reefer charges will be applied to any reefer containers per move based on when the reefer is running. **\$75.00 Imports / \$150.00 Exports**
- CHASSIS CHARGE -** If the steamship does not provide a chassis the charge is daily **\$40.00**
- TRI-AXLE CHARGE -** If a tri-axle chassis is required - daily **\$100.00 (2 day minimum)**
- OW CHARGE -** Overweight charges will be applied on any shipment that exceeds 90,000 lbs cargo and equipment weight **\$50.00**
All fines incurred responsibility of shipper. Must have notification of overweight prior to dispatch to assure driver has overweight permit.
- PER DIEM -** ATS Intermodal, LLC. will not be responsible for any per diem charges from the steamship lines on any container. ATS Intermodal, LLC. requires 48 hours notice in order to p/u and return containers to or from ports.

DETENTION - 1 hr free to load / unload on live shipments 2nd Hour - \$85 / 3rd hour additional - \$150 / 4th hour additional - \$250 / 5th hour additional (layover) - \$350
HAZARDOUS - Must have notification of all hazardous load prior to assure haz-mat qualified driver is dispatched for shipment \$200.00
TANK - If tank certification is required for shipment \$100.00 / per one way
REEFER - Reefer charges will be applied to any reefer containers per move based on when the reefer is running. \$200.00
CHASSIS CHARGE - If the steamship does not provide a chassis the charge is daily \$40.00
TRI-AXLE CHARGE - If a tri-axle chassis is required - daily \$100.00 (2 day minimum)
OW CHARGE - Overweight charges will be applied on any shipment that exceeds 80,000 lbs cargo and equipment weight \$150.00
